#### **DATE AND PLACE**

The championship will be held from 25 to 31 August , 2014 in the City of Lima Perú at the Coliseo Eduardo Dibós located in the District of San Borja.

#### **PARTICIPANTS**

All countries affiliated to the Pan American Karate Federation (PKF) are eligible to participate.

#### **REGISTRATION**

If online registration is available, details will be sent shortly

#### **REGISTRATION COST**

The registration cost will be paid to the Treasurer of the Pan American Karate Federation (PKF) at the moment of accreditation on the dates established in the Program. The registration cost will be US \$ 80.00 per athlete.

#### **INSURANCE**

Compulsory insurance US \$ 10 PER athlete (All federations must pay for insurance unless they present their own valid Insurance)

### AWARDS

Medals are to be awarded for the first place, second place and two third places per trial.

### WEIGHTING

Weighting is to be carried out on August 27. The official weighting will take place from 8 am to 10 am at each official hotel.

### REGULATIONS

The current official regulations of the World Karate Federations (WKF) will be applicable.

### INDIVIDUAL KUMITE

A maximum of two athletes per country and per weight category may participate.

**Categories for AGES: 12 – 13 years; 14-15 years 16-17 years , and 18 – 20 years old**

### TEAM KUMITE

A maximum of one team per country and per category may participate.

### INDIVIDUAL KATA

A maximum of two athletes per country and per category may participate

**Categories for AGES: 12 – 13 years; 14-15 years 16-17 years , and 18 – 20 years old**

### TEAM KATA

A maximum of one team per country and per category may participate.

### UNDER 21

**Important** : According to the provisions of PKF the under 21 categories will be:

**Female: - 50, - 55, - 61, - 68, + 68 kilo**

**Male: - 60, - 67, - 75, - 84, + 84 kilo**

Four tatamis will be used for the competition and a warm-up area will be provided

### TRAINING

Training will be held on August 26 and 27, at the headquarters hotel and/or officials hotels. These training sessions prior booking will be scheduled starting August 25 in the headquarter hotel.

**Important:** If any Official Hotel does not have a training with Tatami, the organization will pay for transportation to the headquarter Hotel in the days and hours of training assigned to each country.

### MEDICAL INSURANCE

The Organizing Committee will be responsible for the First Aid Medical Services at the location of the competition and for the transfer, if necessary, to provide medical assistance or hospitalization if required, which will be covered by the compulsory medical insurance (US\$ 10) paid by each athlete to the **Peruvian Karate Federation (FPK)**

Any national federation that does not pay the medical insurance shall provide proof of a private insurance policy, with any medical assistance required outside the competition being the exclusive responsibility of that federation. Additionally, the federation must sign a Disclaimer.

### TRANSPORT

To guarantee the transport from the airport to the Official Hotels where the delegations will be staying, it will be necessary that these delegations send to the Organizing Committee, at least fifteen (15) days prior to August 25 2014, information including the number of persons, the name of the airline, flight number and time of arrival. The Organizing Committee has estimated that each delegation will have a maximum of two Airport-Officials Hotels-Airport trips and, consequently, each country should pay attention to the arrival of their delegations, in order to avoid individual arrivals that would alter the Airport- Official Hoteles-Airport transport. In the event that a special situation occurs, the delegation or participants shall wait for the general transport with another delegation.

The Organizing Committee is not responsible for the transport to and from the airport of the delegations that do not provide information on their arrival times at least fifteen (15) days in advance, **or of the delegations staying at non-official hotels for the event.**

**The Hotel – Coliseo Eduardo Dibós- Hotel transport will depart from the Officials Hotels assigned by the Organizing Committee.**
