REFEREE COURSE

On the event of the WKF Referee Course and examination that is going to take place from October 31st to November 5th 2018 in Madrid, Spain in the frame of the 24th World Senior Championships, please find below the Online Registration Process and the application form to the WKF Referee Course.

I would like to remind you that the fees for the Referee Course are as follows:

Individual Kata
Individual Kumite
Both Kata & Kumite
License Renewal

350 CHF / 350 EUR / 420 USD
350 CHF / 350 EUR / 660 USD
250 CHF / 250 EUR / 300 USD

Notice: Payment for the Referee Course should be preferably made <u>in person at the registration</u> and **not** by Bank Transfer; if in person, payment has to be done in euro (EUR) or in USD (\$).

The deadline for registration is **August 31**st (2 months before the 1st day of the referee course). For late registration cases, acceptance will be subject to places being available and a surcharge of **300 EUR / 360 USD** for each single late registration (kata or kumite) and of **500 EUR / 600 USD** for each double late registration (kata and kumite). As there is limited capacity for the total number of participants in the referee course, each National Federation will have to rank its candidates by priority order. At latest on September 17th, the WKF Referee Commission will inform the National Federation of the number of candidates accepted, following the priority order indicated by the National Federation. Should this priority order not be given, then the WKF will take the decision as to which candidates will be accepted.

The theory examination for Kata and Kumite will be done by Power Point presentation in English, French and Spanish.

OFFICIATING REFEREES

We would like to remind you that according the WKF communication sent to all National Federations in 2016 and 2017, the WKF Referee Course and examination that is going to take place in Madrid is only for those candidates that have already a WKF qualification (WKF Judge or WKF Referee).

The Course is only for the following officials:

- Candidates that are already at least WKF Judge B in Kumite.
- Candidates that are already at least WKF Judge B in Kata.
- Candidates that would like to obtain a WKF qualification different the one that already has.





The registration of qualified referees for officiating in World Championships will be free of charge when done within the same deadline of <u>August 31st</u> as for the referee course registration (2 months before the 1st day of the referee course). For late registration a surcharge of **300 EUR / 360 USD** will be applied. NFs must register the referees online.

Please remember that in order to attend and officiate at the World Championships all Judges and Referees have to participate in at least two (2) Premier Leagues and one (1) Series-A events in three different continents during this year.
