### **Form Assumption of the Risk and Waiver of Liability Relating to**

### **Coronavirus/COVID-19**

The novel coronavirus ("COVID-19") has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. The World Karate Federation (WKF), Multisport Veneto Event management, ASI Karate VENETO, Destination Italia and Federazione Italiana Judo Lotta Karate Arti Marziali (Fijlkam) has put in place preventative measures to reduce the spread of COVID-19; however, cannot guarantee that you will not become infected with COVID-19. Further, attending any program or activity at the Karate 1 Youth League at the Palainvent could increase your risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 while attending the Karate 1 Youth League at the Palainvent and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Karate 1 Youth League at the Palainvent may result from the actions, omissions, or negligence of myself and others, including, but not limited to the Karate 1 Youth League at the employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance at the Karate 1 Youth League at the Palainvent or ("Claims"). On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless the Karate 1 Youth League organizers, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Karate 1 Youth League organizers, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after attending the Karate 1 Youth League program or activity.
