1. UFAK Referee course registration fees and conditions.

a. Indistinctly Kata or Kumite **b.** Both Kata and Kumite

The online registration deadline for the next examination during the UFAK Championship in Cairo, Egypt is **Friday 19th November 2021**. For late registration cases, acceptance will be subject to availability and a surcharge of **60 EURO** for each single late registration (Kata or Kumite) and of **120 EURO** for each double late registration (Kata and Kumite) will be applied. **Please refer to Point 3 below for further information and the eligibility to register**.

2. Referee license renewal fee (Indistinctly Kata or Kumite, every (4) years)

The license renewal fee is **100 EURO**. A surcharge fee of **60 EURO** will be applied in the case of a late payment.

3. E-Learning November – December 2020 condition for registration.

Referees who intend to take the UFAK Judge B examination MUST have attended the UFAK E-Learning Course which held from November - December 2020. Those who did not attend the course and intend taking the examination will only be allowed based on availability after those who met the conditions have registered. However, they MUST pay the surcharge of **60 EURO** for each single late registration (Kata or Kumite) and of **120 EURO** for each double late registration (Kata and Kumite).

4. UFAK Referee List 2021 conditions.

All the referees who have not participated in the African Championships and have not renewed their License within six (6) years; will be **removed from the UFAK Referees list**,
